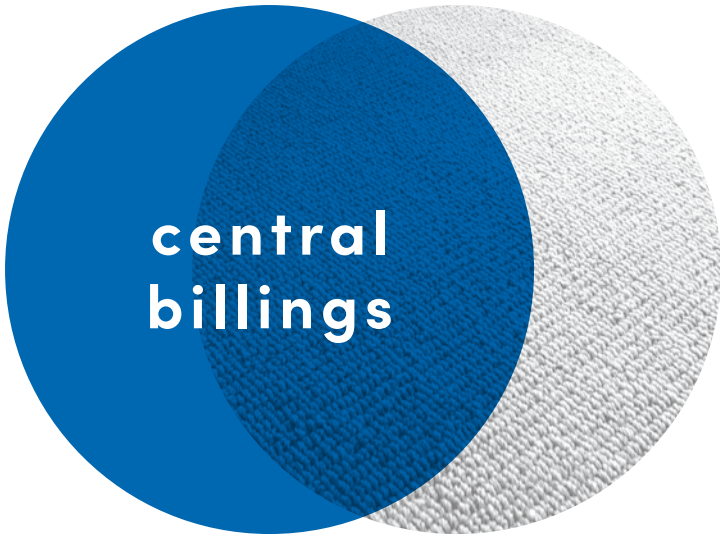

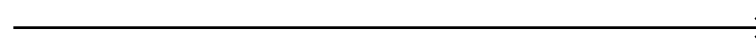

- ✓ overdue account
